Separate sealed bids to replace an existing concrete slab bridge with a precast reinforced concrete box culvert on HUMMEL ROAD, RIC-CR171-0.85, SHARON TOWNSHIP, RICHLAND COUNTY, OHIO will be received by the Richland County Board of Commissioners, County Administration Building, 50 Park Avenue East, Mansfield, Ohio 44902 UNTIL 10:30 AM LOCAL TIME JULY 27, 2017 and then at said office publicly opened and read aloud.

Plans and bid documents shall be obtained at RICHLAND BLUE PRINT.COM, INC., 1069 Park Ave. West, Mansfield, OH 44906 (Telephone Number 419-524-2781). The bidder must obtain the plans, specifications, etc. at their own expense and the cost is non-refundable. The plans and specifications may be obtained after July 4, 2017, 2017.

Each proposal must contain the full name of the party or parties making the same and all persons interested therein, and must be accompanied, pursuant to Section 153.54 of the Ohio Revised Code, by a satisfactory BID GUARANTY: either a BID BOND or a BID AND PERFORMANCE PAYMENT BOND executed by the bidder and an acceptable surety, in an amount equal to one hundred percent (100%) of the total amount for each individual proposal; OR by a certified check, cashiers check, or a letter of credit pursuant to Chapter 1305 of the Ohio Revised Code in an amount equal to ten percent (10%) of the total amount for each individual proposal, payable to Richland County Board of Commissioners as a guarantee that if the proposal is accepted, a contract will be entered into.

The Owner reserves the right to waive any informalities or to reject any or all bids.

Each bidder must have current ODOT prequalification for WORKTYPE 20, LEVEL 1 BRIDGE, and present their Certificate of Qualification at the time of the bid opening.

A valid Certificate of Compliance with Affirmative Action Programs, issued by the State EEO Coordinator dated prior to the date fixed for the opening of bids to be presented at the time of the bid opening.

Attention of bidders is particularly called to the prevailing wage rates to be paid under the contract.

ENCOURAGING DIVERSITY, GROWTH AND EQUITY (EDGE) REQUIREMENT. EDGE participation goals have been set on this project. The goal may be met if the Contractor is EDGE certified or by subcontracting to certified EDGE firms.
